SUMMER CAMP FAQ'S

WHAT SHOULD MY CHILD(REN) BRING TO CAMP EACH DAY?

- **Water Bottle - please label your water bottle with your child(ren) first & last name**
 - Make sure to drink plenty of water at home before arriving at camp & make sure to drink plenty of water at home in the evening after camp to stay hydrated
- **Sunscreen**
- **Comfortable walking shoes – NO FLIP FLOPS**
- **Camp t-Shirt & uniform (Gi) pants (if they have some) OR Camp-t-shirt, comfortable shorts & sneakers**
- **Swim suit and towel (for swimming / field trip day)**

LET US KNOW IF YOUR CHILD(REN) HAS/HAVE ANY FOOD ALLERGIES.

WHAT SHOULD MY CHILD(REN) WEAR TO CAMP EACH DAY?

- **Everyday campers should come dressed in their CAMP T-SHIRT and uniform pants (Gi) (if they have some), or shorts, t-shirt & sneakers. No flip flops or open-toed shoes!**
- **Students who are new to karate will have the option of ordering a Gi (uniform – jacket, pants, & belt) if desired, for an additional \$30 upon registering for camp.**
- **PLEASE LABEL ALL ITEMS WITH STUDENTS FULL NAME (FIRST AND LAST).**
- **School Patches may be purchased for an additional \$10 per patch, for students who purchase a Gi**

WHAT NOT TO BRING TO CAMP EACH DAY?

- Video games – or other hand held devices
- iPods – no mp3 players of any kind are allowed

DROP-OFF / PICK-UP

- ALL PARENTS WILL SIGN-IN AND SIGN-OUT THEIR CHILD(REN) DAILY. AT PICK-UP, ALL PARENTS MUST SIGN-OUT THEIR CHILDREN.
- If someone other than the parent will be picking-up their child(ren) we must be notified IN ADVANCE by email or in writing, otherwise, we will not let the child(ren) go until a parent is contacted and the change is confirmed.
 - Please email our office at Sensei@WhiteCraneMartialArts.com at least 24 hrs notice of any pick-up changes.
- Walkers and bikers must have written permission from their parents before we will let them leave.

DAILY SCHEDULE:

- Doors open at 9:00 am for Normal Hours Drop Off and 8:00 am for Extended Hours Drop Off– campers should be picked up at 4:00 or 5:00 pm, depending on the type of schedule you signed up for.
- If your child(ren) is dropped off before 8:30 am, a flat fee of \$20 will be charged for that day only. This fee will be automatically billed and you will receive an invoice.
- If your child(ren) is not picked up by 4:00 or 5:00 pm (depending on your enrollment type), a flat fee of \$20 will be charged for that day only. This fee will be automatically billed and you will receive an invoice.

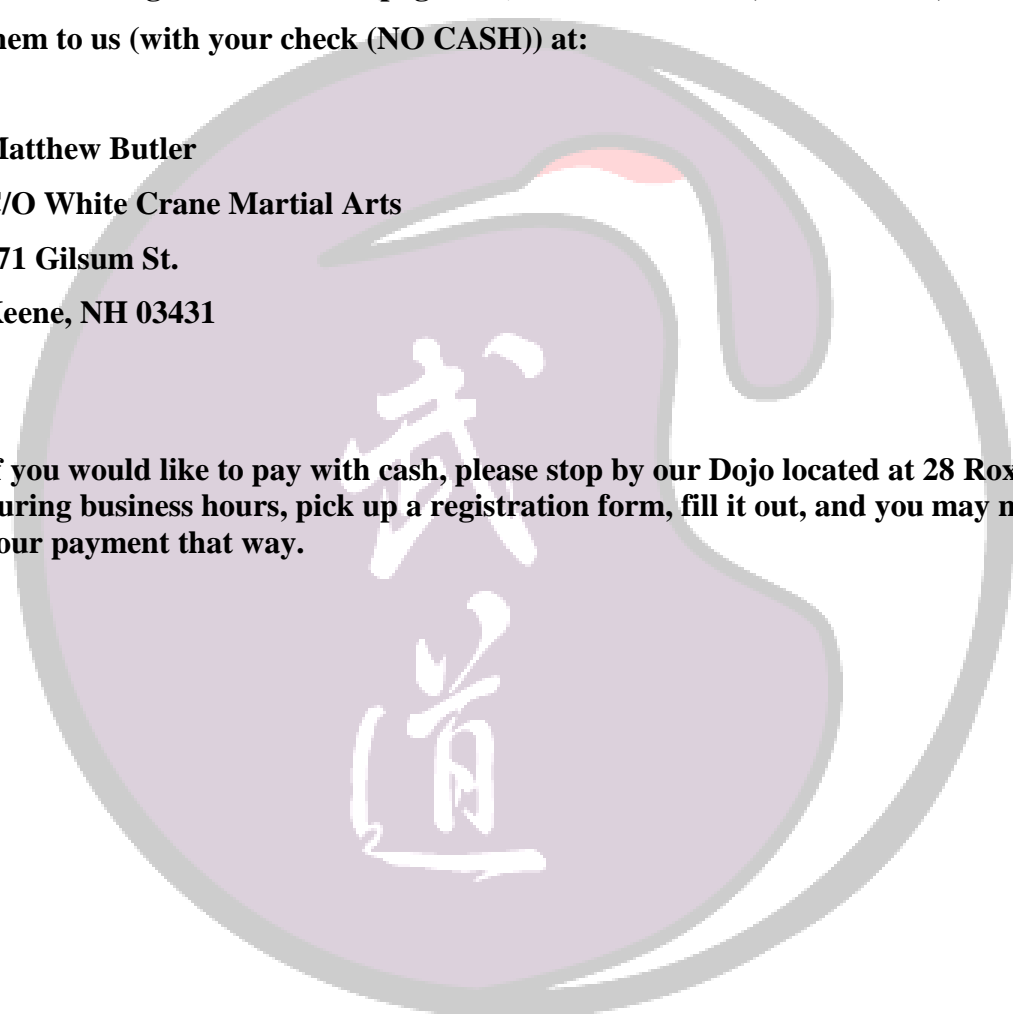

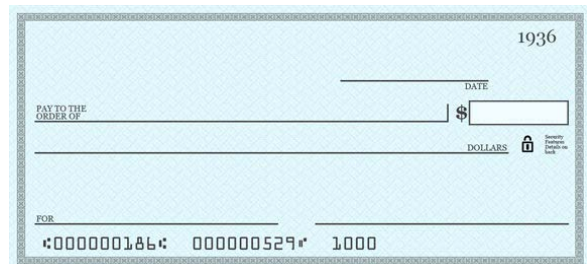
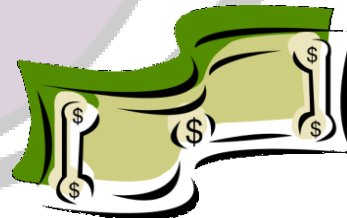
